Overview

The Partnership

In partnership with Central Coast Group Training (CCGT) and myHomecare, ET Australia Training College is looking for entry level staff to fill multiple part time traineeship vacancies in home and community care.

Why a Pre-Traineeship Program?

CCGT and myHomecare will use the one-day pre-traineeship program to select suitable candidates for paid traineeship employment.

To be considered for traineeship employment, applicants must participate in this one-day pre-traineeship program.

CCGT and myHomecare will be using the program to gain an insight into each applicant to determine their suitability for potential traineeship employment.

What's included in the Pre-Traineeship Program?

Suitable applicants will be invited to attend the one-day pre-traineeship program during which time they will find out about the traineeship roles on offer, the home and community care industry and will be introduced to some of the industry terminology.

Applicants will have the opportunity to find about each of the partnering organisations to gain an understanding of how the organisations will work together throughout the traineeship period. Applicants will have the opportunity to engage with the employer and ask questions.

Applicants will find out about the employer's recruitment process for the traineeship positions should they be invited to formally apply.

The pre-traineeship program provides an opportunity to receive support and advice to assist students to make an informed decision about traineeship employment if an offer of traineeship employment is made.

This pre-traineeship program is provided at **no cost** to eligible participants. Students are not paid to participate in the pre-traineeship program.

Entry Requirements

All applicants must be screened for suitability / eligibility for selection into the one-day program.

Home and community care work can be physically challenging and is very hands on. Applicants must have the functional capacity and fitness to perform the tasks and duties necessary to work in the home and community care sector if successful in gaining traineeship employment. Applicants who, due to fitness or functional capacity, would place themselves or others at risk of harm or injury would be unsuitable for the program.

Applicants are required to have good communication and interpersonal skills.

Basic numeracy and literacy skills are needed for this program.

Applicants must demonstrate a level of maturity and discretion as this will be required for work in home and community care.

Prior to being present on site at ET Australia, students must provide evidence of being fully vaccinated against COVID-19.

Employment Opportunities

This is a pathway program which will lead into traineeship employment for suitable candidates. CCGT and myHomecare will be selecting people to formally apply for the part time traineeship positions on conclusion of the one-day session.

Further Study

This program is a pathway program and those successful in gaining traineeship employment with CCGT and MyHomecare will go on to complete the CHC33015 Certificate III in Individual Support (Ageing) qualification.

This program will be delivered in a classroom setting over one day.
